## Commercial Litigation Attorneys Author Implied Waiver of Privilege Article for *Boston Bar Journal*

Partner Jonathan Handler, counsel Jillian Hirsch and associate Emily Zandy contributed an article to the spring edition of the *Boston Bar Journal*. In the article, "The Sword and the Shield Revisited: Developments in the Implied Waiver of Privilege," the attorneys discuss the ramifications of recent court decisions in Massachusetts for the implied waiver of attorney-client privilege and the work product doctrine. They write that *Clair v. Clair* and *Columbia Data Products v. Autonomy Corp. Ltd.* "[make] clear that litigants cannot use privileged material as both a sword and a shield. In other words, litigants may not base their legal positions on privileged material while simultaneously denying their opponent access to that information on the ground that it is privileged."
