Day Pitney LLP has been recognized in the 2026 edition of Best Law Firms® and has been named "Law Firm of the Year" for Trusts & Estates for the third time, in addition to earning top-tier national and regional rankings. The firm was previously recognized in the 2021 and 2022 editions of Best Law Firms with the "Law Firm of the Year" designation for Trusts & Estates.
