## Michael Byrne Named Managing Partner of Day Pitney

### ***New Leadership Appointments Announced for Executive Committee, Executive Board, and Energy Practice***

Day Pitney LLP's partners elected [Michael P. Byrne](#) as Managing Partner of the firm, effective April 2. Byrne succeeds [Gregory A. Hayes](#), who is stepping down as Managing Partner and will focus exclusively on his private client practice. Hayes served eight years on the firm's Executive Committee, including three years as Managing Partner.

Since spring 2023, Day Pitney has added 40 partners, including 21 lateral hires and 19 partner promotions, deepening its presence in key markets, with significant expansion in Boston, Florida, New Jersey, and Washington, D.C. These investments reflect a truly regional platform with nationally recognized practices that serve clients in complex, high-stakes matters.

As Managing Partner, Byrne will initially focus on two core initiatives—a deliberate, partnership-driven strategic growth plan and the implementation of innovative and emerging technologies, including artificial intelligence. In his first months as Managing Partner, he will also conduct a structured listening tour and strategic review designed to align the firm around clear priorities and opportunities for growth.

In addition to his leadership role, Byrne will continue his commercial real estate transactions practice, representing a broad range of clients on real estate finance transactions, acquisitions, dispositions, leasing, development, and joint ventures. His clients include life insurance companies, banks, pension funds, investment banks, commercial lenders, corporations, private equity funds, religious organizations, utility companies, and high-net-worth individuals.
