## Former Southern District Prosecutor Sarah Krissoff Joins Day Pitney's White Collar Practice in New York

She also led, among others, investigations combatting sex trafficking and crimes against children, racketeering, murder, Hobbs Act robbery, international narcotics trafficking, gun trafficking, arson, and bank robbery.

"Day Pitney has a notable reputation for guiding clients through complex criminal and regulatory challenges," said Krissoff. "I am eager to add to the team's deep bench of skilled trial attorneys, and to assist our clients as they navigate difficult cases and vigorously advocate for them when they go to trial."

During her government tenure, Krissoff was also detailed to the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), where she was Acting Deputy Chief Counsel, the ATF's second-highest attorney at the time. As an AUSA in the Southern District, Krissoff also served on the Hiring Committee and the Pro Bono Program Committee.

Krissoff was a recipient of the 2017 Attorney General's Award for Exceptional Service, the highest award given by the Department of Justice, and a 2012 Federal Prosecutor of the Year award from the Federal Law Enforcement Foundation. Most recently, she was nominated for the 2021 Women in Federal Law Enforcement Prosecutor of the Year.

Krissoff earned her B.A. from Brown University and her J.D. from Columbia University School of Law. She is admitted to practice in New York.
