HBRA of Connecticut Honors Elizabeth Barton with 2014 "Distinguished Service Award"

She provided her services in a case that is "critically important" to the organization, according to the HBRA of Connecticut's Chief Executive Officer Bill Ethier. "Beth has more than 20 years of experience in environmental and land use consultation, permitting and litigation and we are really grateful to have her on our side in this issue," Ethier said.

In addition to her litigation practice, Ms. Barton's work at Day Pitney involves substantial contact with federal agencies, including the United States Environmental Protection Agency and the Army Corps of Engineers, and with state agencies, including the Connecticut Department of Energy and Environmental Protection and the Connecticut Department of Health Services.
