Among the cases where Mullins has served as arbitration counsel was a series of large-dollar disputes involving asbestos non-products losses. In a separate action, he was trial counsel in a complex insurance coverage case in federal court concerning alleged business interruption losses, in which damages were sought in excess of \$100 million. Mullins successfully tried the damages portion of the case to a jury after obtaining summary judgment, eliminating any bad faith exposure.

"Day Pitney's insurance and reinsurance lawyers have a strong reputation for offering sophisticated legal counsel on some of the industry's thorniest legal problems," said Mullins. "The firm has a depth of experience and a national platform that are a great fit for me and my practice."
