Shah played a critical role in the initial funding of the SABAC Endowed Fund Scholarship, created in collaboration with the Hartford Foundation for Public Giving.

Shah previously was recognized by South Asian Bar Association of North America with their Cornerstone Award in 2022. Additionally, she was listed as a "Woman Worth Watching," by *Profiles of Diversity Journal* and a "Woman of Power," by the Urban League of Southern Connecticut. Shah received her J.D., *magna cum laude*, from Boston University School of Law and her B.S., *magna cum laude*, from the University of Connecticut.
