## Chambers USA 2010 Ranks 40 Day Pitney Attorneys

Day Pitney continues to move up in the rankings compiled by Chambers & Partners? - *Chambers USA 2010, America's Leading Lawyers for Business.*

In all, 40 attorneys and 16 practices received national and regional rankings in the prestigious guide, which was released today. Five practices received Band 1 rankings in their respective regions.
