Earlier at PepsiCo, Tamoney was division counsel for Pepsi-Cola North America, serving as lead lawyer for domestic beverage issues from 1989-1999. Prior to that, he spent six years as division counsel for Europe, the Middle East and Africa, overseeing international transactions and general corporate affairs across all PepsiCo food and beverage divisions in those parts of the world. Tamoney began working at PepsiCo in 1978, focusing on mergers and acquisitions, securities, taxation and finance matters.
