Mr. Cash was deeply involved in much of the legislation developed after the 9/11 attacks, including the USA-Patriot Act, the Department of Homeland Security Act, and the Intelligence Reform and Terrorism Prevention Act, which created the position of Director of National Intelligence.

"Day Pitney continues to invest in bringing on board top litigators," said Dennis LaFiura, the firm's Litigation Department Chair. "We think Steve will be an incredible asset to our expanding trial team capabilities.
